Candidates need to submit relevant proofs of their qualifications, age, experience etc. along with the application and the original documents at the time of interview. No Objection Certificate (NOC) from employee in case of employed candidates.
4. No TA/DA will be paid to the candidates appearing for interview.
5. The candidates will have no claim for his/her continuation of service as well as claim for appointment on regular establishment in the service/s of COVAS/MAFSU/ICAR Establishment. The posts will be discontinued with termination of the project.
